1. Interpretation and definitions

Unless otherwise stated, words or expressions contained in this constitution shall bear the same meaning as in the National Health Service Act 2006 as amended by the Health and Social Care Act 2012

Words importing the masculine gender only shall include the feminine gender; words importing the singular shall import the plural and vice-versa

the 2006 Act is the National Health Service Act 2006.

the 2012 Act is the Health and Social Care Act 2012.

Annual Members Meeting has the meaning given to it defined in paragraph 13 of the constitution

constitution means this constitution and all annexes to it.

Monitor is the corporate body known as Monitor, the Independent Regulator of NHS Foundation Trusts, as provided by Section 34 of the 2012 Act.

terms of Authorisation are the terms of authorisation issued by Monitor under Section 35 of the 2006 Act.

the Accounting Officer is the person who from time to time discharges the functions specified in paragraph 25(5) of Schedule 7 to the 2006 Act.

2. Name

The name of the foundation trust is Airedale NHS Foundation Trust (the trust).¹ (Note 1)

3. Principal purpose (Note 2)

3.1 The principal purpose of the trust is the provision of goods and services for the purposes of the health service in England.² (Note 2)

3.2 The trust does not fulfil its principal purpose unless, in each financial year, its total income from the provision of goods and services for

the purposes of the health service in England is greater than its total income from the provision of goods and services for any other purposes.

3.3 The trust may provide goods and services for any purposes related to—

3.3.1 the provision of services provided to individuals for or in connection with the prevention, diagnosis or treatment of illness, and

3.1.13.3.2 the promotion and protection of public health.

3.4 The trust may also carry on activities other than those mentioned in the above paragraph for the purpose of making additional income available in order better to carry on its principal purpose.

5.4. Powers

5.14.1 The powers of the trust are set out in the 2006 Act.³ *(Note 3)*

5.24.2 **All** ~~T~~ the powers of the trust shall be exercised by the Board of Directors on behalf of the trust.

5.34.3 Any of these powers may be delegated to a committee of directors or to an executive director.

6.5. Membership and constituencies *(Note 4)*

The trust shall have members, each of whom shall be a member of one of the following constituencies:

6.15.1 a public constituency

6.25.2 a staff constituency **[and**

6.35.3 a patients' constituency⁴] - not applicable

7.6. Application for membership

An individual who is eligible to become a member of the trust may do so on application to the trust.

8.7. Public Constituency

9.8. Staff Constituency

~~9.18.1~~ An individual who is employed by the trust under a contract of employment with the trust may become or continue as a member of the trust provided:

~~9.1.18.1.1~~ _____ he is employed by the trust under a contract of employment which has no fixed term or has a fixed term of at least 12 months; or

~~9.1.28.1.2~~ _____ he has been continuously employed by the trust under a contract of employment for at least 12 months.

~~9.28.2~~ Individuals who exercise functions for the purposes of the trust, otherwise than under a contract of employment with the trust, may become or continue as members of the staff constituency provided such individuals have exercised these functions continuously for a period of at least 12 months. (*optional*)

~~9.38.3~~ Those individuals who are eligible for membership of the trust by reason of the previous provisions are referred to collectively as the Staff Constituency.

10.9. [Automatic membership by default – staff] (optional—Note 10**)⁹**

10.19.1 An individual who is:

10.1.19.1.1 eligible to become a member of the Staff Constituency, and

10.1.29.1.2 invited by the trust to become a member of the Staff Constituency [and a member of the appropriate class within the Staff Constituency],

shall become a member of the trust as a member of the Staff Constituency [and appropriate class within the Staff Constituency] without an application being made, unless he informs the trust that he does not wish to do so.

11.10. [Patients' Constituency] (not applicable—Note 5**)¹⁰**

11.110.1 An individual who has, within the period specified below, attended any of the trust's hospitals as either a patient or as the carer of a patient may become a member of the trust.

11.210.2 The period referred to above shall be the period of [] years immediately preceding the date of an application by the patient or carer to become a member of the trust.

11.310.3 Those individuals who are eligible for membership of the trust by reason of the previous provisions are referred to collectively as the Patients' Constituency.

11.410.4 [The Patients' Constituency shall be divided into [specify the number – at least 3] descriptions of individuals who are eligible for

13.12. Restriction on membership

13.112.1 An individual who is a member of a constituency, or of a class within a constituency, may not while membership of that constituency or class continues, be a member of any other constituency or class.

13.212.2 An individual who satisfies the criteria for membership of the Staff Constituency may not become or continue as a member of any constituency other than the Staff Constituency.

13.312.3 An individual must be at least [] years old to become a member of the trust.

12.4 [Further provisions as to the circumstances in which an individual may not become or continue as a member of the trust are set out in Annex 9 – Further Provisions.]¹⁴ (Note 32)

13. Annual Members' Meeting¹⁵

13.1 The Trust shall hold an annual meeting of its members ('Annual Members' Meeting'). The Annual Members' Meeting shall be open to members of the public.

13.2 [Further provisions about the Annual Members' Meeting are set out in Annex 10 – Annual Members' Meeting].

14. Board of Governors Council of Governors – composition

11. (Notes 13 to 18)

13.414.1 The trust is to have a Board of Governors Council of Governors¹⁶, which shall comprise both elected and appointed governors.

13.514.2 The composition of the Board of Governors Council of Governors is specified in Annex 4.

~~13.6~~14.3 The members of the ~~Board of Governors~~Council of Governors, other than the appointed members, shall be chosen by election by their constituency or, where there are classes within a constituency, by their class within that constituency. The number of governors to be elected by each constituency, or, where appropriate, by each class of each constituency, is specified in Annex 4.¹⁷ (~~Note 19~~)

14.15. Board of Governors Council of Governors – election of governors

~~14.1~~15.1 Elections for elected members of the ~~Board of Governors~~Council of Governors shall be conducted in accordance with the Model Election Rules.

~~14.2~~15.2 The Model Election Rules as published from time to time by the Department of Health form part of this constitution. The Model Election Rules current at the date of the trust's Authorisation are attached at Annex 5.

~~14.3~~15.3 A subsequent variation of the Model Election Rules by the Department of Health shall not constitute a variation of the terms of this constitution for the purposes of paragraph ~~48 []~~41 of the constitution (amendment of the constitution).

~~14.4~~15.4 An election, if contested, shall be by secret ballot.

15.16. Board of Governors Council of Governors - tenure

~~15.1~~16.1 An elected governor may hold office for a period of up to [3 years].

~~15.2~~16.2 An elected governor shall cease to hold office if he ceases to be a member of the constituency or class by which he was elected.

~~15.3~~16.3 An elected governor shall be eligible for re-election at the end of his term.

~~15.4~~16.4 An appointed governor may hold office for a period of up to [] years.

~~15.5~~16.5 An appointed governor shall cease to hold office if the appointing organisation withdraws its sponsorship of him.

~~15.6~~16.6 An appointed governor shall be eligible for re-appointment at

16.17. Board of Governors Council of Governors – disqualification and removal

16.1.17.1 The following may not become or continue as a member of the **Board of Governors Council of Governors**:

16.1.17.1.1 a person who has been adjudged bankrupt or whose estate has been sequestrated and (in either case) has not been discharged;

16.1.17.1.2 a person who has made a composition or arrangement with, or granted a trust deed for, his creditors and has not been discharged in respect of it;

16.1.17.1.3 a person who within the preceding five years has been convicted in the British Islands of any offence if a sentence of imprisonment (whether suspended or not) for a period of not less than three months (without the option of a fine) was imposed on him.

16.217.2 Governors must be at least [16] years of age at the date they are nominated for election or appointment.¹⁸ (Note 20)

16.317.3 [Further provisions as to the circumstances in which an individual may not become or continue as a member of the Board of Governors are set out in Annex 6.] (optional—Note 24)¹⁹

17.4 [The constitution is to make provision for the removal of governors. – added - Further provisions as to the circumstances for the removal of governors are set out in Annex 5 (Note 22)]

18. Council of Governors – duties of governors

18.1 The general duties of the Council of Governors are –

18.1.1 to hold the non-executive directors individually and collectively to account for the performance of the Board of Directors, and

18.1.2 to represent the interests of the members of the trust

as a whole and the interests of the public.²⁰

18.2 The Trust must take steps to secure that the governors are equipped with the skills and knowledge they require in their capacity as such.²¹

17-19. Board of Governors Council of Governors – meetings of governors

17-19.1 The Chairman of the trust (i.e. the Chairman of the Board of Directors, appointed in accordance with the provisions of paragraph 22.1 or paragraph 23.1 below) or, in his absence [another person], [the Deputy Chairman (appointed in accordance with the provisions of paragraph 24 below)], shall preside at meetings of the Board of Governors Council of Governors.

15-19.2 Meetings of the Board of Governors Council of Governors shall be open to members of the public. [Members of the public may be excluded from a meeting for special reasons.]²² (Note 23)

19.3 For the purposes of obtaining information about the trust's performance of its functions or the directors' performance of their duties (and deciding whether to propose a vote on the Trust's or directors' performance), the Council of Governors may require one or more of the directors to attend a meeting.²³

18-20. Board of Governors Council of Governors – standing orders

The standing orders for the practice and procedure of the Board of Governors are attached at Annex 7.

21. Council of Governors – referral to the Panel²⁴

21.1 In this paragraph, the Panel means a panel of persons appointed by Monitor to which a governor of an NHS foundation trust may refer a question as to whether the trust has failed or is failing—

21.1.1 to act in accordance with its constitution, or

21.1.2 to act in accordance with provision made by or under Chapter 5 of the 2006 Act.

21.2 A governor may refer a question to the Panel only if more than half of

the members of the Council of Governors voting approve the referral.

19-22. Board of Governors Council of Governors - conflicts of interest of governors

If a governor has a pecuniary, personal or family interest, whether that interest is actual or potential and whether that interest is direct or indirect, in any proposed contract or other matter which is under consideration or is to be considered by the Board of Governors Council of Governors, the governor shall disclose that interest to the members of the Board of Governors Council of Governors as soon as he becomes aware of it. The Standing Orders for the Board of Governors Council of Governors shall make provision for the disclosure of interests and arrangements for the exclusion of a governor declaring any interest from any discussion or consideration of the matter in respect of which an interest has been disclosed.

20-23. Board of Governors Council of Governors – travel expenses

The trust may pay travelling and other expenses to members of the Board of Governors at rates determined by the trust.

21-24. Board of Governors Council of Governors – further provisions (optional – Note 24)²⁵

Further provisions with respect to the Board of Governors Council of Governors are set out in Annex 6.]

22-25. Board of Directors – composition (Note 25)

22-25.1 The trust is to have a Board of Directors, which shall comprise both executive and non-executive directors.²⁶

22-25.2 The Board of Directors is to comprise:

22-25.2.1 a non-executive Chairman

22-25.2.2 [] other non-executive directors; and

22-25.2.3 [] executive directors.
